A motion was made by R : W : Stanley L. Hudson, Deputy Grand Master, and seconded by R : W : Richard G. Hoover, Senior Grand Warden, to approve the Minutes of Corporate Board Meeting No. 11 of October 17, 2015, and Poll No. 12 of October 24, 2015. Motion carried.

ADMINISTRATOR'S REPORT – NOVEMBER

- There are 5 articles in each Board Member packet this month regarding trends in senior living which may be of interest and stress the importance of retirement care and services now and in the near future.
- The draft of a poster and a letter introducing the Lodge Bonus Incentive Program to assist new residents of the Masonic Home is ready for final review by the Board Members for approval, printing and distribution to the Lodges.

LONG RANGE PLANNING COMMITTEE REPORT - NOVEMBER

1. Latite Roofing Representative Scott Thompson has stated to the Maintenance Director that the roofing repairs were completed as of October 30, 2015. He has further indicated to the Maintenance Director that the corrective actions will be inspected by the St. Petersburg Building Department for the issuance of the Certificate of Completion. Upon receipt of the final inspection, the GAF Product Warranty and Workmanship Guarantee will be provided to the Masonic Home for our acceptance and approval.

- 2. The Long Range Planning Committee is reviewing, for future projects, the estimates for reroofing the Administration Building, the Chiller Deck, the Boardroom, and the Library Area. The existing leaks in these areas have been repaired, as approved previously. The Chiller Deck re-roof has been identified as the highest priority with a \$60,000 estimated cost.
- 3. The contract for pest control services has been terminated with Hughes Pest Control as of November 30, 2015. The Board of Trustees will review the proposals and present a contract for approval at the December 2015 Board of Trustees Meeting.
- 4. The Masonic Home Staff has completed the required two hour OSHA Training by Stericycle, Inc. The required OSHA training for the Maintenance Staff's Job Code Specialty Training is being scheduled by the Maintenance Director.
- 5. The Guest House revised permit plans documents are ready to be submitted to the Building Department for final review and are scheduled for delivery as soon as possible.
- 6. The First Lady's Project has been approved by the Board of Trustees for the aesthetic upgrades to the Masonic Home Beauty Shop. The conceptual project budget has been presented with project start-up set for early January 2016.

The Report of the Maintenance Director is submitted as part of this report.

FUNDS RECEIVED FOR THE MASONIC HOME ENDOWMENT FUND, INC. FUNDS AVAILABLE FOR THE MASONIC HOME BUILDING FUND

The Board reviewed the funds received through the month of October for the Masonic Home Endowment Fund, Inc. (\$143,984.31). The Board then reviewed the funds available for the Masonic Home Building Fund (\$226,866.11).

MASONIC RELIEF FUND - OCTOBER

There were no donations to the Masonic Relief Fund to report for the month of October.

R : W : John E. Karroum, Junior Grand Warden, moved for acceptance of the report for October. Second was made by R : W : Thomas L. Turlington, P.D.D.G.M., and the motion carried.

MASONIC HOME BUDGET REPORT - OCTOBER

We are 12.35% (\$1,027,164.33) under budget for the fiscal year after amortizing for the insurance premium already paid.

R : W : John E. Karroum, Junior Grand Warden, made a motion for acceptance of the report for October as printed and distributed which was seconded by R : W : Thomas L. Turlington, P.D.D.G.M., and the motion carried.

The Grand Master then called upon R:W: Stephen R. Gladstone, General Counsel. General Counsel informed the Board of a situation whereby the children of Private Pay Resident William B. Loft have petitioned the court to have Brother Loft moved to where they live in Canada. The Court appointed an Attorney as Guardian Ad Litem to represent Brother Loft. The Guardian Ad Litem has asked that the

Administrator of the Masonic Home and the Certified Nursing Assistant who cares for the resident testify in court as to the care Brother Loft is receiving at the Masonic Home. General Counsel contacted the Guardian Ad Litem who indicated that if they do not voluntarily testify that he will subpoena the Administrator and the C.N.A. General Counsel explained that the Guardian Ad Litem agreed to only ask for testimony concerning the care Brother Loft is receiving in the Masonic Home and not to ask their opinion as to whether Brother Loft should be moved to a facility in Canada or to testify as to the ability of a facility in Canada to care for Brother Loft. General Counsel feels that the Administrator and the C.N.A. should testify under this agreement and asked the Board for their blessing. After discussion, the Members of the Corporate Board indicated their agreement that the Administrator and the C.N.A. should testify only to the care that Brother Loft is receiving at the Masonic Home.
